- Includes conference registration, hotel & travel expenses

Application Requirements

- Application Form
- Current Resume
- Letters of Recommendations (3 required)
- BOMA Good Standing Letter from your local
- Personal Statement/Essay

Condition of Acceptance

- Attend the full conference in Philadelphia, PA
- Take part in at least one of the Education Tracks
- Attend the PSW Regional Meeting
- Submit a summary of their experience after the conference

Qualifications

- Less than 5years' experience in CRE
- Active BOMA Member within the Pacific Southwest Region(PSW)
- Applicant must be in good standing with the BOMA local, PSW Region and International
- Applicant must agree with the conditions of acceptance

2024 Pacific Southwest BOMA Emerging Young Leaders Scholarship Scholarship Requirement Summary

Qualifications:

1. Applicant must have less than 5 years' experience in the commercial real estate industry (in the property management or service provider field).
2. Applicant must be an active BOMA Member involved in business functions as defined within their local BOMA.
3. Applicant's BOMA Membership must be within the Pacific Southwest Region (PSW), defined as a BOMA located in Arizona, California, Hawaii, or Nevada.
4. Applicant must be in good standing with the BOMA local, PSW Region and International.
5. Applicant must agree with the conditions of acceptance stated below.

Conditions of Acceptance:

1. The recipient must attend the full conference to participate in one of the Education Tracks made available and attend the PSW Regional meeting.
2. The scholarship scope includes reimbursement up to \$2,500 for 2024 full conference registration at the early bird rate, up to three nights of hotel and travel (to and from the conference location) to facilitate attendance at the 2024 BOMA International Conference & Expo in Philadelphia, PA on July 13-16, 2024.
3. Within 30 days of conference completion, submit a report to the PSW Scholarship Committee recapping the Conference Experience as a whole and particular benefit(s) realized.
4. Reimbursement of applicable conference expenses will require copies of all receipts. Airfare will be eligible for reimbursement at the time of purchase. All remaining expenses will be eligible for reimbursement after the required report has been submitted. Expense reimbursement is required to be submitted within 45 days of the conference completion.

Application Requirements: (Incomplete packages will not be considered)

1. Scholarship Application
2. Resume: Must be current and include personal, professional, & educational Information, current contact information, academic achievements, community and BOMA participation highlighted.
3. Letter of Recommendations (three in total):
 - a. Current employer with the Conditions of Acceptance clearly accepted on the letter.
 - b. PSW BOMA Local Board of Directors Member. (Include confirmation of BOMA membership)
 - c. One of the below letters:
 - i. PSW BOMA Member, in good standing. (Include confirmation of BOMA membership)
 - ii. Community CRE Leader or Professor in the Real Estate field.
4. Confirmation from your local BOMA Executive Director clarifying that you are a member in good standing.
5. Brief personal essay (1 page max): Describe your financial need, why you desire the scholarship, and how you will meet the conditions of the scholarship acceptance.
6. All required documents above, six pages minimum, are to be bundled into one PDF package. Submissions with multiple attachments will not be accepted.

Process & Timeline:

1. Submission period deadline is **February 29, 2024**. Phone interviews will be set up between March 18th-22th and the winner will be notified by March 29, 2024.

3. The Recipient will be announced throughout the Pacific Southwest BOMA Region, as well as, at the Awardee's local BOMA chapter.
